#### What's New - SC21 Activity Update 1.8

- 1. The SC21 Steering Board was held on 18<sup>th</sup> December 2017 @ ADS London. Main topics discussed:
  - a. The SC21 Steering Board is committed to the deployment of C+G in 2018
  - b. The SC21 Steering Board is committed to engage with Government regarding central

funding.

- c. In the meantime, the SC21 Steering Board instructed the SC21 PO to continue to develop and explore alternative funding routes /models to enable the Standard National Framework to be deployed flexibly at a local level (NW, SW (iAero), NI, Midlands, Scotland, and Wales, etc.
- d. 2018 Objectives:
  - Formally launch SC21 Competitiveness & Growth (incorporating NMCL) , including selecting Improvement Module provider by Farnborough Air Show 2018
  - ii. To establish a pipeline/waterfall analysis to enable true progression from Programme registration, through Bronze, Silver, Gold, and OE to C+G
  - iii. To finalise the future roles and responsibilities of SC21 Partners and Practitioner to more effectively deploy SC21 at the Participants. to be completed by May 2018
  - iv. Establish a data capture roadmap to achieving a "portal" type solution by end of 2019. This should include how it will be funded. Roadmap to be in presented by June 2018 Steering Board.

- 3. The <u>Performance Standards Submission Template</u> Version 1 has started to be used from some of the companies submitting for a Performance Standard.



## 2. SC21 Competitiveness + Growth (Future programme)

- 1. We continue to discuss the implications and details of the Government announcement on NMCL for Automotive sector, and how central funding can still be achieved.
- 2. Despite the disappointment of apparently reverting back to a "sector deal" approach for funding, this has not changed ADS and the A+D Industry commitment to deploying SC21 C+G in 2018.
- 3. Further Industry resource has been identified to support the provider selection process for the 126 approved Improvement Modules.
- All initial Aerospace Capability Assessments pilots have now been concluded with very positive feedback.
- 5. Engagement with regions/area continues with proposals underway for South West (iAero), Northern Ireland developing, including alternative funding mechanisms.
