### Pressure Groups seek to try to add to the US Government's Human Rights "Blacklist"

A group of anti-corruption and non-government organisations is seeking wider implementation of US sanctions targeting kleptocrats and human rights abusers. Nearly 30 organisations, led by Human Rights First, sent a letter on 5<sup>th</sup> March to Treasury Secretary, Steven Mnuchin, and Secretary of State, Rex Tillerson, saying they were disappointed with the first imposition of sanctions under the Global Magnitsky Act (<a href="https://www.state.gov/e/eb/tfs/spi/globalmagnitsky/index.htm">https://www.state.gov/e/eb/tfs/spi/globalmagnitsky/index.htm</a>), an expanded version of a 2012 law targeting Russian human rights abusers. The initial round targeted, amongst others, a former Chinese security official, the daughter of a former Uzbek president and a billionaire Israeli businessman linked to "blood diamonds". It stated that the rollout, whilst welcome, did not go far enough, because it did not target human rights abusers and corrupt actors in parts of the world where such acts are well documented. "We urge you to avoid selective application of this powerful tool," the letter said.
